

What is your reasoning behind wanting to serve on the St. Mary Parish Council? I would like to serve not just District 1 but all of St. Mary Parish as a whole to give the citizens good solid government and have town hall meetings to hear their complaints and concerns to see how we can solve them.

I'm Craig Alonzo Mathews #89 on your ballot, and a current resident of Sorrel. However, I was raised in Four Corners. My collegiate undergraduate studies were completed at Grambling State University where I obtained my Bachelor of Science Degree in Business Marketing (Spring 994). After college, I relocated home in pursuit of a long-term career in nonprofit community development and the empowerment of all people in St. Mary Parish.

For the past five years I have served as Chief Executive Officer with St. Martin Iberia Lafayette Community Action Agency (SMILE). I am also one of the founding partners of PediaKare De' Louisiana, LLC (Lafayette), a Pediatric Medical Daycare Center, as well as several other private business interests. I am married to the former Christine Charles and together we have three children, 34, 28, and 21. My leadership experience also includes Senior Pastor at Hubbard United Church of Christ in Gueydan for the past combined 9 years. Prior to this appointment I served as a Youth Pastor for a combined 16 years at St. Moses Baptist Church in Sorrell, Faith Hope Christian Fellowship of Abbeville, and Zion Hill Christian Fellowship of New Iberia.

My professional track record is evidence that I've chosen a life and career dedicated to leadership in public service across all aspects. My career began as the first and founding Housing Development Director of Southern Mutual Help Association's Housing Development Corporation. Through my personal passion in healthcare administration, I've led the development of numerous comprehensive initiatives to improve rural access to high quality care for our citizens. Moreover, I have innovated multifarious childcare and youth development programs for "at-risk" youths. I have been fundamentally engaged in economic and business development efforts in St. Mary Parish. I have advocated in our local school system for numerous collaborative projects to strengthen community engagement in academia and enhance student and school performance.

I previously served for 7 years as the Senior Grant Writer and Program Planner at St. Mary CAA, and for the past 17 years as a member of the Board of Directors. I previously served as Board Chairman of the Acadiana Regional Coalition on Homelessness and Housing (ARCH), which includes St. Mary Parish among the other 8 Parishes that are seeking to eradicate homelessness in our communities, among many other responsibilities. Throughout these combined experiences, I've procured over \$110,000,000 in combined federal, state and private foundation grant and contract funds within numerous communities across the state of Louisiana and in neighboring states. For the past eight years I have served as Finance Committee Chairman for St. Mary Parish Council, and as a board member for the Acadiana Workforce Development Board-40, serving our eight-parish region, including St. Mary.

I am confident that I am the most competent candidate on your ballot for District I, and plan to resume this Office with the courage, integrity and fortitude that is necessary to help move our entire parish forward by placing FAMILIES & COMMUNITIES AHEAD OF POLITICS. Remember, LEADERS are born, not elected!

What is your reasoning behind wanting to serve on the St. Mary Parish Council? Serving in public office requires a genuine love and compassion for others, particularly those that are less fortunate. In many instances I've questioned internally whether public office is something I desire to pursue/continue. However, it has become quite evident to me through the past four terms I've served as the District I Councilman, that I didn't choose this path. Rather, I was chosen for this very purpose! The stakes are too high in this current political climate to risk our local government falling into the hands of selfish people whose chief concern and priority is themselves and their own agendas.

It is time for St. Mary Parish to catch up to the surrounding parishes that are exceeding us in growth and development, while more of our families relocate to other areas that can offer a better quality of life. I am confident that our Parish has the potential and resources necessary to shift this paradigm and become more competitive in terms of economic opportunity, affordable housing development, job creation, better infrastructure, and enhanced education and healthcare. I believe that I possess the skillsets and experience to help lead that effort.

### If elected, what is your plan to work with the Parish Government and the Municipality(s) of out district to bring new businesses to our Parish?

One of the primary considerations of investors and developers when exploring location options is taxes. We have a huge challenge of having very high mileages / taxes in St. Mary, particularly in the west end. We need to work together with some of our local political subdivisions (Boards) to consolidate those entities where possible, which over time can eventually lower some of those mileages and perhaps even eliminate some. We also need more collaboration and cohesiveness among our Parish Government and the other municipalities to streamline resources and work smarter rather than everyone operating on an individual island of their own.

The disenfranchisement of certain unincorporated communities of the Parish – namely those scattered throughout District 1 must be overcome to close the gaps and eliminate poverty and the lack of access to much need resources that other communities in St. Mary and surrounding Parishes enjoy. We cannot build a bigger and better St. Mary without leveling the playing field and creating economic opportunity for everyone in our Parish.

What do you see as the biggest challenge for our Parish and how do you propose to tackle that challenge?

The biggest challenge for St. Mary is the lack of safe, decent, and affordable housing – both multi-family rental property and single-family homeownership opportunities. We unequivocally must relax on some of the restrictions and resistance that seems to prevent such developers from proceeding with and realizing these important accomplishments. I've personally witnessed multiple failed attempts of some very skilled and wealthy experts at what could have been very successful upscale multifamily or apartment complex housing developments over the past decade right here in this Parish, because of reasons that if I began to describe would perhaps bring any reasonably sane person to a pause!

In reality, many of the families that have come to St. Mary Parish to work in some of the jobs that have been created in our Parish now live in neighboring Parishes that are benefiting directly from taxes that they could have been contributing to St. Mary. Even as we raise our families and our children enter the workforce, without a healthy housing stock they will have no choice but to leave St. Mary Parish and seek a life for themselves and their families. I've personally experienced this with my own children.

Do you believe lawsuits against the energy industry would harm St. Mary Parish's economy, why or why not, and would you work to prevent these lawsuits? Yes, I do believe that these lawsuits, when frivolous, have the potential to create more harm to an already fragile economy in St. Mary Parish and across the state of Louisiana. We are fortunate to still be able to hold on to the little industrial growth that comes through energy production. Unless there are some measures instituted to limit the gross abuse of the judicial system which brings the insurmountable congestion this type of litigation creates, Louisiana and St. Mary Parish will continue to lose economic opportunity and become less competitive.

There are still a lot of drainage and roadway issues that exist around St. Mary Parish. How do you propose Parish Government aid in improving those issues? St. Mary Parish, like many other rural parishes, is "cash poor". While the Parish Council and Administration have worked cooperatively to avoid operating in a deficit over the years I've served in this capacity, it is absolutely necessary that we seize opportunities to periodically leverage economic investment through bonds in order to make necessary infrastructure improvements such as roads, water and sewer plants, drainage systems, etc.

We have been very creative in achieving these results. Although, there are still areas that desperately need to be addressed, and this takes time. This strategy must also be complimented by working collectively with our state Legislature and Congress to leverage additional state and federal investments that can increase the rate of return by making a greater impact when those dollars are added to a project portfolio. One great example would be the Road Repair Initiative we implemented over the last three years, which allowed us to resurface and overlay a significant percentage of the substandard roadways that had been neglected across the Parish for the past 30 years.

How could the Parish Council support more things to do for children in our area? I am proud to say that I have laid the foundation for a proper response to this critical issue throughout my terms in this office! The key to the Parish Council's response to the need for more comprehensive youth empowerment activities lies within our seven Recreation Districts. Most of these Districts/Boards have a dedicated revenue source from which comprehensive programs can be created that will support our children's experiences growing up in rural St. Mary. The challenge is to collaborate in a meaningful way that brings the greatest inspirational impact parish-wide.

I would propose the creation of a parish government position for a recreation director or liaison that could work with all districts to bring the cohesion necessary to ensure that no community or neighborhood would be void of recreational activities. We could also ensure that while rec districts would maintain their own sense of individuality, there would also be some regimented course or curriculum that would be culturally diverse in scope to reflect the demographics of our entire parish. This would take significant thought and commitment from our parish leaders, but it could certainly enhance our current offerings to children and youths.

What are your plans to support the local businesses already in existence in our Parish? I have made it my personal priority and always encourage others to shop locally instead of traveling outside of the Parish for goods and services, where possible. I also believe that we must do more internally to promote local businesses and ensure that all our citizens are aware of the businesses that exist.

On a grander scale, it is absolutely mandatory that all local governmental units in St. Mary Parish be intentional about educating and empowering local entrepreneurs to participate in the public bidding process when there are public projects being developed. I keep hearing the excuse "They must be qualified to bid." Well, lets help

them to become qualified! I would like to have the Parish Government work together with our legislators, local municipalities, and federal agencies to host a series of seminars that will train small business owners in the steps to become qualified bidders on all local government projects.

We have built a beautiful state of the art multipurpose room at Bayou Bend Wellness Center that should be filled to capacity with interested parties hoping to become future bidders on these projects! There is no excuse to continue building in this Parish and awarding those MILLIONS OF DOLLARS to outside contractors and subcontractors! IT IS LUDICROUS TO NOT EMPOWER AND BUILD WEALTH AMONG OUR OWN NEIGHBORS! Not to mention, it also shameful.

### In your opinion, what are the two most important qualities that candidates for Parish Council should posses?

The two most important qualities that a serious candidate for ANY public office MUST possess are integrity and compassion. Proverbs 29:2 says, "When the righteous are in authority, the people rejoice; But when a wicked man rules, the people groan." Unfortunately, there will always be people to rise to power and authority that are self-driven and unconcerned about the plight of others. However, when righteous men and women gain seats at the decision-making table it creates a greater sense of accountability and reasoning, which makes it a little bit more difficult to totally disregard others.

I believe there are obvious differences among "politicians" and "public servants". By my summation, politicians are self-serving and seek to further their own interests. On the contrary, public servants are truly concerned about the well-being of others and as it is written in Philippians 2:3-4 "Do nothing from selfish ambition or conceit, but in humility count others more significant than yourselves. Let each of you look not only to his own interests, but also to the interests of others."

#### What would be the most immediate change that you would push for in our Parish?

The most immediate change that needs to happen at the Parish Council level is a common-sense consensus among the majority members to seriously look at the Home Rule Charter and get some of these antiquated articles that were written in the early 80's amended to reflect present-day culture and progression to create a more fair, equitable, and just form of local government FOR ALL THE PEOPLE.

In the event of the return of lockdowns, what is your stance on the lockdowns when it cases local businesses and our children to suffer?

While I do remain very sensitive to the dangers associated with anything as serious as the COVID-19 Pandemic we experienced recently, I also believe there are measures that can be taken locally to ensure that our people and our economy never suffers the devastation of 2020-2021. For example, I believe that we should still be able to operate our local economy by mandating that very limited numbers of citizens are allowed to enter public spaces at any given time, such as regulating times that smaller groups of people are allowed to go out at a given time and day.

This is done by the government all the time when it comes to subsidy programs like SNAP, Medicare, IRS tax refunds, etc. You are allowed access when your name or number is called. We can implement similar measures that would allow business to resume, although at a limited rate.

Do you believe lawsuits against the energy industry would harm St. Mary Parish's economy? Why or why not? And would you work to prevent these lawsuits? Any lawsuits against our energy industry would be detrimental to our economy in this Parish. I would oppose any lawsuits that would harm our industry in St. Mary Parish in the future.

There are still a lot of drainage and roadway issues that exist around St. Mary Parish. How do you propose Parish Government aid in improving those issues?

I have always been a proponent of improving our roadways and drainage. Recently I have worked with our C.A.O. for the purchase of an asphalt zipper and new asphalt truck so that we are able to start doing our own repairs and chip sealing some of our existing roads. I work extremely well with our drainage department whenever residents contact me with complaints about ditches that need cleaning out. Because of my previous experience, I have been able to aid in making the improvements to several of the boat landings.

If re-elected, I intend to continue to push forward on future projects by working with our State Senator and Representative with whom I have a good working relationship. There are still many roads and bridges that are in need of replacement or repair.

How could the Parish Council support more things to do for children in our area? Over the past 4 years, I have supported the local Rec Districts by funding the new pavilion at the Centerville Park and the new pavilion at Broussard-Harris Park in Franklin. I have worked with the Rec District and the School Board for future projects at the Centerville baseball field. I have helped with the funding for the Caffrey Park improvements. Our children are a fundamental part of our parish community and I will always support those projects that are needed.

What are your plans to support the local businesses already in existence in our Parish? Established businesses need to know that there will be no more additional tax burdens placed on them. Everyone in the parish needs to support their local businesses and work together to grow those businesses. I am also a major proponent of the commercial shrimping industry which is on the verge of collapse. I have been going to Washington DC for the past 6 years to meet with lawmakers in an attempt to keep this industry profitable and intact because this industry is vital to our Parish's culture and economics. I will continue to fight for this industry and all other industries that need support.

We must protect that which is vital for St. Mary Parish. They are being held accountable for destroying wetlands and creating canals that harm our coastal parishes. I would stand firm with the council, and adjoining parishes Lafourche an Terrebonne on the No vote. I understand the consequences of losing jobs are being brought up, but if we lose our marshes and wetlands there is more at stake than just jobs. Settling is not going to repair all the damage that has been done.

There are still a lot of drainage and roadway issues that exist around St. Mary Parish. How do you propose Parish Government aid in improving those issues?

Trees and shrubbery need to be adequately disposed of so as not to impede the drainage culverts. When flooding occurs large cut logs, limbs, branches are washed into culverts and drainage ditches get stuck in culverts creating more flooding situations. There are currently 2 parish debris trucks working in St. Mary Parish. I propose we purchase another vehicle to tackle the load that is put on the parish. I personally have witnessed furniture and trees sitting on the side of he road for weeks on end. Either the parish wasn't notified of the debris, or they were working on the other side of the parish.

How could the Parish Council support more things to do for children in our area?

Obtaining waterfront property to put a boat launch would be excellent. Mr. Ramsey had a good idea, but he location wasn't sufficient. I appreciate the effort by the recreation department with putt putt golf. But with temperatures soaring into the 100's no one wanted to go stand in the sun. I think an addition to the water park, not just for small children but something for adolescents, would be good. We need to find something for our 11 to 14 year old group. We need to keep our children from drug dealers which I was told were hanging out at the skate park and in the parking lost by the restrooms. Step up neighborhood watch by the park area by the public to keep our children safe. It was a good way for a student from Bayou Vista to meet kids from Berwick and Patterson and keep them out of trouble. It is possible to speak with local churches and see if a weekend dance would be possible at one of their locations.

What are your plans to support the local businesses already in existence in our Parish?

I would visit with owners and corporate managers on what they feel the issues are when it comes to growth and expansion of their business. Moving forward with a realistic plan of action that fits their criteria.

In your opinion, what are the TWO most important qualities that candidates for Parish Council should possess?

Honesty and Transparency

What would be the most immediate change you would push for in our Parish? I would like to have rapid expansion in community-based initiatives to facilitate public participation in decision making where the community is invited to engage besides voting.

### What do you see as the biggest challenge for our Parish and how do you propose to tackle that challenge?

There are too many challenges to narrow down to one. A few of the most important challenges are Taxation, Fiscal Responsibility, Modernization, Decreasing Population, and Economic Development/Jobs. According to a 2022 Analysis St. Mary Parish is ranked 47 of 62 parishes for Household income. According to the 2023 NICHE Best Places Rankings St. Mary Parish is ranked 44 of 62 parishes. My objective to address the crime issue is to introduce a resolution to create a Crime Prevention and Security District to provide extra patrols in the affected areas. To tackle taxation I will propose that we hire a full time grant writer, so we don't have to rely on tax payers to get projects funded. As for Fiscal Responsibility, I propose better oversight of local boards and making sure board members are appointed based on ability and instead of personal connection. Modernization is a huge issue that has many aspects. I believe we should have a set standard for parish boards, remodel all community centers via grants, and update the Charter. The last 3 coincide, we have to get the right people, diversify to bring new industry which will create jobs, retain people, and draw people here.

Do you believe lawsuits against the energy industry would harm St. Mary Parish's economy? Why or why not? And would you work to prevent these lawsuits? Yes, I am the only candidate in my race for Parish Council District 4 to have formally met and engaged with the Louisiana Oil and Gas Association and I fully understand how much of an issue frivolous litigation is to the energy industry. When a business in our parish is attacked, it affects our economy because it may cause a reduction in jobs, increase in regulations, or worst-case scenario a loss of the business completely. I will work diligently to prevent these lawsuits. I was invited to attend the Energize the Vote event September 14th, which is Sponsored by Louisiana Oil and Gas Association, Louisiana Mid-Continental Oil and Gas Association, and the Grow Louisiana Coalition. I also happen to be the only Candidate in St. Mary Parish to go to this event.

There are still a lot of drainage and roadway issues that exist around St. Mary Parish. How do you propose Parish Government aid in improving those issues? Parish Government should have had a full time Grant Writer to capitalize on the billions of dollars that is available from the Federal Infrastructure Bill. Going forward we should get a Grant Writer and pursue these fund so we can get these improvements taken care of without putting any tax burdens on the citizens of St. Mary Parish. I am fully aware of the drainage issues in Bayou Vista and across the tracks in Patterson and I plan to work on these issues as soon as possible.

How could the Parish Council support more things to do for children in our area? There are several ways the Parish Council can support Recreation for the children. As the Immediate past Chairman of St. Mary Parish Recreation District 3 and the Louisiana Recreation and Parks Association District 2 I am the only candidate equipped to tackle the recreation issues. I am working on a plan to get an Indoor Gun Range in Bayou Vista, Update the Tennis Courts to a Multi Sports Court that would incorporate Tennis, Basketball, Pickle Ball, and Volleyball in a covered area with lights. I have consulted with other Recreation districts within 17 parishes including St. Mary Parish. There are many grants designed to renovate playgrounds and Community Centers available. I believe the Parish should reinstate the Recreation Department and follow how neighboring Parishes are structuring there Recreation. The recreation districts in the Parish as a whole need guidance from a Certified Parks and Recreation Professional. One standard for all districts will help.

### What are your plans to support the local businesses already in existence in our Parish?

My plan is to first, establish communication with business owners and local officials to understand the challenges of businesses whether it be taxes, incentives, or regulations and evaluate how these conditions can be improved to retain business. As a current member of the Industrial Development Board, I will work with the Economic Development Director to increase awareness of the Bonds that the board offers to new and expanding businesses. I believe we should have events throughout the Parish to support small businesses such as Town Market events. Personally, I would hate to lose any business in St. Mary Parish that is why I am currently fighting to keep Dominque's Dance Studio here in Bayou Vista.

### In your opinion, what are the TWO most important qualities that candidates for Parish Council should possess?

The two most important qualities that Parish Council candidates should possess is Integrity and Transparency. We need individuals that will do the right thing even when the right thing is not the popular decision to make. Candidates should honor the Oath that they take to uphold the Constitution. There should be no backhanded deals, conflicts of interest, trading of votes, or division amongst the Parish Council. As far as transparency goes, I tie in Communication with this quality. In order to be transparent one must be able and willing to have open communication. Elected officials should be forthcoming with what is going on with each other as well as with the Community. There are many projects throughout the parish that can be funded by grants, such as Drainage Pumps, Recreation improvements, Parish building renovations, and infrastructure improvements. Utilizing grants is of course a benefit to taxpayers because no tax burden is needed if the grant funds the project. Grants can effect Economic Development by funding an expansion or renovation project, which in turn creates jobs. Also within my first 100 days I will push for

monthly Town hall meetings, Indoor Gun Range in Bayou Vista, Increase Recreation projects for the youth, drainage improvements in both Bayou Vista and my part Patterson, and creating a Crime Prevention and Security District to keep citizens of St. Mary safe.

In the event of the return of lockdowns, what is your stance of the lockdowns when it causes local businesses and our children to suffer?

#### What is your reasoning behind wanting to serve on the St. Mary Parish Council?

Public service is particularly important to me.In fact, my entire life has been one of public service, as evidenced by my years with the St. Mary Parish Sherrif's Office, the Louisiana Wildlife and Fisheries, and as a volunteer with the Morgan City Police Department Reserve Program and currently with the City of Morgan City Marshall's Office Reserve Program. I like helping people and getting things done for them. It is my hope to continue serving the people with another four years as your St. Mary Parish Councilman for District 5. In addition, I want to finish the work that I started during my first term and, consequently, continue delivering for the people of the 5th District and the parish in the next four years.

### If elected, what is your plan to work with the Parish Government and the municipality of your district to bring new businesses to our Parish?

As a parish councilman, it is my duty to represent the people of my district which means I must collaborate with others to get things accomplished, including bringing new businesses to the parish and helping existing businesses. Working with our state and federal delegations, state officials and agencies, parish officials, private businesses, and others is key to providing a suitable location for businesses to thrive. It is important that we do all that we can to provide a business climate that allows them to expand. We must ensure that taxes are not overburdensome, infrastructure (e.g., roadways, drainage, electricity, etc.) is adequate and dependable, housing is available for workers, and marketing of this parish is effective, just to name a few things needed. In addition, we need to keep our insurance rates low and affordable. Plus, it is critical that our two parish ports have the proper resources to keep them open for trade, especially in the export/import business.

All of this requires funding, so we should look at not only local funds, but we should make every effort to secure federal grant monies, especially infrastructure funds that have been recently appropriated to communities throughout the United States.

### What do you see as the biggest challenge for our Parish and how do you propose to tackle that challenge?

Frankly, I see two big challenges facing the parish. One, insurance rates are climbing and making living in St. Mary Parish a hardship. Flood insurance and housing insurance is causing our fellow citizens to have to make painful decisions in what they can afford to do, buy, eat, etc. It's not fair, and I, as a parish councilman, can encourage our state's Insurance Department to do what needs to be done to lower homeowners' insurance rates and work with the federal delegation to lower the costs for flood insurance. Yes, I know that this is a tough challenge, but it is one that I accept and will work with my parish colleagues to get done. Also, housing is the other large challenge we face in St. Mary. We need places for our families to live in, and we need housing for employees. It will be difficult to attract businesses to St. Mary Parish if there is no place for their employees to live.

#### Do you believe lawsuits against the energy industry would harm St. Mary Parish's economy? Why or why not? And would you work to prevent these lawsuits?

Simply stated, I am against lawsuits against the energy industry! During this past term in office, it was my honor to join my fellow councilmembers and vote 11-0 against pursuing a lawsuit against various parties in the energy industry. I think suing these businesses is counter to business sense, especially since the state of Louisiana permitted their work. I am definitely against these lawsuits because they crush businesses, and this will make oil companies leave this area, putting good, hard-working people out of work, and leaving no one to eat at our restaurants, buy merchandise/goods at local stores, and so on. The results of energy lawsuits will have a "domino effect" on other businesses, causing them to fail. Plus, we need to remember that with a smaller tax base, less tax revenue will be collected by governmental agencies. This will result in government reducing services to the people, such as street and drainage repairs, new bridges, recreation programs, law enforcement, fire protection, etc. This could cause our fire ratings to increase resulting in higher premiums for fire insurance.

### There are still a lot of drainage and roadway issues that exist around St. Mary Parish. How do you propose Parish Government aid in improving those issues?

It is my belief that the parish can't fix these problems on its own. We will need additional monies from Baton Rouge and from the federal government; and, we can apply for the recent infrastructure grants that have been awarded to communities throughout the United States and even to some entities in St. Mary Parish; however, St. Mary Parish has to be more aggressive in pursuing these funds to help pay the costs for these drainage and roadway issues. As a parish councilman, I believe that we must collaborate with other entities, like the drainage district, for example, to ensure that our drainage canals are clear of debris so waters can flow away from our homes and businesses. In addition, we must look at the state's "Road Royalty" funds that come to the parish and are intended to maintain our roads. Instead of using them for grass cuttings, perhaps the parish administration should look to using these funds for roadwork so as to keep our vehicles from being damaged

#### How could the Parish Council support more things to do for children in our area?

The parish currently provides approximately \$2.2 million to parish recreation districts through a 3/10 cent's property and sales tax. We should look at increasing funding to the recreation districts, not necessarily through an increase in taxes, but, rather, we need to look into grant funds to help fund activities related to children and even adults. Communities throughout the country are securing funds through private foundation grants and funding from state and federal government sources. The parish council needs to encourage the next parish administration to fight for these funds to help with programs directed towards the children of our area. I can tell you that I worked with our state senator Bret Allain II to secure over \$266,000 in funding from the state's Capital Outlay Program to Kemper Williams Park for enhancements that will provide children with new things to do. Plus, parish councilmembers must work together as a whole and not District vs. District or East vs. West to get things done. For the parish to move forward, the entire parish must work together.

What are your plans to support the local businesses already in existence in our Parish? I am a big believer in marketing and promotions when it comes to businesses; therefore, I would encourage a "Buy Local" program to energize businesses and locals to purchase from local businesses. Plus, as councilman, I would like to encourage our parish tourist commission and Chamber of Commerce to look into an aggressive promotional and marketing campaign to attract people to St. Mary Parish to shop at our stores and visit our local attractions. Plus, I encourage the Tourist Commission and Chamber to continue offering classes that can help businesses with promotions, marketing, business operations, etc. to help them grow and improve. In addition, we must make sure that the infrastructure is conducive to conducting business, such as nice roads and drainage (to prevent flooding).

### In your opinion, what are the TWO most important qualities that candidates for Parish Council should possess?

Forget what a candidate should possess, let's look at two important qualities that a council member should possess. A candidate can tell you what you want to hear to get elected; but, a sitting council member should have two important traits. One, the councilmember must be willing to work with others to get something done. I am confident that I have proven to people that I am able to work with others and that I do, thus getting things delivered for the people of District 5. Second, a parish council member should have a vision of where he or she would like to see his/her district and the parish in 5-to-10 years. Without some sort of idea of where you would like to be in the future, we will get nowhere. Only working together as an entire parish, and not with an East/West mindset, will get us to a future that is prosperous for all, including our children and grandchildren.

What would be the most immediate change that you would push for in our Parish? I would like to see St. Mary Parish have a full-time parish president with an aggressive job description who could promote the parish throughout Louisiana, the country and world trying to recruit businesses and tourists to St. Mary Parish. In addition, this full-time parish president should be in BR and in Washington, D.C. chasing down dollars for the parish to help fund projects that will benefit the people and businesses of the parish.

In the event of the return of lockdowns, what is your stance on the lockdowns when it causes local businesses and our children to suffer?

I am against lockdowns because they hurt our economy by closing businesses and our children because they are not in school learning and interacting with other children. I will not support lockdowns. They do not work and have a horrible effect on our lives and freedoms.

Do you believe lawsuits against the energy industry would harm St. Mary Parish's economy? Why or why not? And would you work to prevent these lawsuits? Any insignificant lawsuit against the oil industry risks business development and progression in our parish. Therefore, I do not support these types of lawsuits. That said, there are litigations that were coastal based that were filed by the attorney general's office and the governor that the parish government has no control over whether we participate in them or not. These energy lawsuits fund some of the coastal restoration projects. Thus, to say that I completely oppose the lawsuit, would mean refusing access to critical restoration funds that could benefit St. Mary Parish.

There are still a lot of drainage and roadway issues that exist around St. Mary Parish. How do you propose Parish Government aid in improving those issues? Most of the drainage issues are dealt with through the drainage boards. Because of this, I believe that we should continue to improve the way we monitor their use of people's tax dollars. This is done by participating in their monthly meetings and having open communication with board members. Furthermore, as we always done, we should assist them with applications for capital outlay projects or grants. This will allow us to improve funding for additional and much needed projects that may include resurfacing roads and improving drainage in St. Mary Parish.

How could the Parish Council support more things to do for children in our area? We have a lot of underutilized resources regarding parish funded parks and recreation departments. Therefore, there needs to be better cooperation between each of these separate parks and recreation departments across St. Mary Parish. Our charter allows for a park and recreation director that oversees all activities and divisions. This position could ensure that the board is utilizing their resources appropriately to better our community for our children. Therefore, I propose that we reestablish this position where he or she will report directly to the parish council. Until we have efficiency in that area, we are never going to have enough facilities in one park location to be able support these bigger sports tournaments (soccer, baseball, etc.). If we have someone who focuses on improving and monitoring our different recreational offices, it will allow more tourism in our area, resulting in increased revenue. These extra funds will allow us to make additional improvements and create different activities for our children to participate in.

### What are your plans to support the local businesses already in existence in our Parish?

First, I want to make it clear that our small businesses play a key role in unlocking our parish's true potential. That said, we as a council need to figure out the true needs of our local businesses in St. Mary Parish. I believe that we should further help them with receiving permits to expand their development. This will range from getting repairs for improvements to branching out to different locations throughout the parish. Additionally, I think that we should assist our business owners by finding the appropriate ways to cut taxes. Giving our local businesses viable tax breaks will allow them to have the income to grow and expand, resulting in a stronger economy for St. Mary Parish. This will allow our people to remain in the parish as they will able to expand their operations and have more employment opportunities.

## In your opinion, what are the TWO most important qualities that candidates for Parish Council should possess?

I believe that relatability is the most important quality in a candidate. I think that we need a parish councilman that represents ALL the people, not just a certain demographic. The people of this parish need to know who represents them, so they can feel comfortable talking about their ideas, thoughts, complaints, etc. I also think that integrity is an important quality that a candidate should have. If you do not build trust and strength with the people, you cannot succeed as a parish councilman. No number of connections and resources can override the need for one to be strong enough to tackle and challenge the important issues. A leader without that quality will deliver inconsistent results that will only hurt St. Mary Parish.

#### What would be the most immediate change that you would push for in our Parish?

I think the most immediate change that we should push is the better structure of our parish boards, i.e., drainage, sewage, recreation, etc. These entities are the largest consumer of tax dollars. Therefore, we need to ensure that these boards are not carelessly spending taxpayer dollars on transactions that will not benefit St. Mary Parish. We can do this by closely monitoring each of their budgets, and making sure they are transparent regarding their spending.

In the event of the return of lockdowns, what is your stance on the lockdowns when it causes local businesses and our children to suffer?

Most lockdowns are state and federally mandated and out of the control of the parish government. If a lockdown does occur, I believe that we must do what we can to help local businesses in their time of need. This involves giving funding and finding alternative ways of doing business that are specified for each individual business. This will allow our parish to continue to prosper. Regarding our children, the St. Mary Parish School Board has control over how the schools manage a lockdown, exempting the private schools. Furthermore, the parish council cannot control the actions of the school board as they operate independently. #### How could the Parish Council support more things for children to do in our area?

I feel working with Young Memorial \ SLCC to assist and communicate training opportunities and skills for our citizens. If feel if a business is thinking of moving to St. Mary Parish, they need to know they will have good, trained employees to hire to start their business and to maintain their business.

I would review tax structure to ensure we do not over taxing the businesses. We must work together as a parish.

## What do you see as the biggest challenge for our Parish and how to you propose to tackle that challenge?

I think the biggest challenge is promoting St. Mary Parish as a place to live and raise your family. Through the years I have heard there is nothing in St. Mary Parish for younger generation to stay and raise their family. Many friends and family moved out. We need to work to transition from a negative narrative to a positive narrative.

I think starts with changing the narrative of our local and parish government by becoming united with a message that St. Mary Parish Government works for the citizens of St. Mary Parish. I feel we need to promote, promote, and promote more, by working together as one.

Do you believe lawsuits against the energy industry would harm St. Mary Parish's economy? Why or why not? And would you work to prevent these lawsuits?

I feel lawsuits against the energy industry could harm St. Mary Parish's economy but if the lawsuits are warranted then the energy industry needs to be held responsible for any incidents which could negatively affect St. Mary Parish.

If energy companies have the fear of being sued on a regular basis, then I feel they choose to go elsewhere. I would not work to prevent lawsuits if they are warranted.

There are still a lot of drainage and roadway issues that exist around St. Mary Parish. How do you propose Parish Government aid in improving those issues?

I feel we need to continue to have good drainage districts with good board members to ensure the tax dollars are being spent wisely.

I feel drainage studies would show the most efficient locations for pumping stations in some communities that this has not happened in.

I feel we need to visit with our local state representatives – Beryl Amedee and Vinny St. Blanc along with who will represent St. Mary Parish in Senate District 21 on a regular basis to assist getting drainage and roadway funding from the state and federal government. Having a strong rapport and relationship with the state and federal government is vital to help resolve these issues.

#### How could the Parish Council support more things to do for children in our area?

Being in the medical field for over 29 years and working throughout the Bayou Region, I have witnessed health fairs focusing on children and their needs. I feel organizing children health care events through our local recreation districts and St. Mary Parish Schools. I feel many local businesses and citizens would be happy to sponsor and assist with such events. I feel working with recreation districts to brainstorm and be creative with physical and educational activities. The key is to work together as one.

What are your plans to support the local businesses already in existence in our Parish?

Working closely with St. Mary Parish Chamber is vital. We need to continue to support the chamber so they can continue to support local business. I think promoting "shop local" events are very important which can be done on a regular basis.

Be able to listen with a purpose to your fellow council members will provide an open mind to concerns which will give a better view on the situation to produce the best resolution.

The second quality is the ability to communicate. If you are not able to explain and speak well on the issues to the citizens, then that can create confusion, anxiety, anger and undo stress. I feel a councilman should be able to speak on facts and truth.

#### What would be the most immediate change that you would push for in our Parish?
