Qualifying fees are set in accordance with R.S. 18:464(B). In accordance with 18:464 (D) the St. Mary Parish Democratic Executive Committee and the Republican Parish Executive Committee have assessed an additional fee equal to one-half of the qualifying fee established by law.

R.S. 18:464 (A) requires that the qualifying must be paid in cash, certified check, cashier's check or money order. Personal checks can not be accepted.
